Eligibility Criteria and Terms & Conditions for the Post of 1. General Physician, 2. Physiotherapist (Female), 3. Young Professional and 4. Masseur Grade-I (Female) [Contractual]

1. GENERAL PHYSICIAN (Contractual):-

a) Qualifications:

Essential: MBBS Degree from any recognized Indian or Foreign University and should compulsorily be registered with Medical Council of India / State. Masters in Sports / Diploma in Sports / Fellowship in Sports will be preferred.

Experience: Minimum 5 years of experience including working with sports academies/ Institutions / National & International Sports Team.

b) Age Limit: The candidate must not have attained 60 years of age as on the closing date of advertisement.

c) Remuneration: Fixed remuneration of **Rs. 60,000/-** (Sixty Thousand only) per month.

d) Selection Criteria: The following weightages shall be assigned to different parameters in the selection process:

The shortlisted candidates will be called for the interview and assessed as follows:

Qualification	70 marks (50 marks for essential qualification & up to 20 marks for relevant higher qualification)
Interview	30 marks
Total	100 marks

Note:- The breakup of 10 marks for such higher qualification shall be considered as follows:

- i) Where a Bachelor's degree in the relevant field (MBBS) is the minimum prescribed qualification, 5 marks shall be given to a Post-Graduation (PG) degree (e.g. MD/MS).
- ii) The PG qualification in Anesthesiology/Dermatology, Venereology and Leprosy/Family Medicine/General Medicine/Pediatrics/Palliative Medicine/Pathology /Psychiatry/Radio-Diagnosis/Radiology/Tuberculosis and Respiratory diseases/Emergency and Critical care/Ear, Nose and Throat/General Surgery/Ophthalmology/Orthopedics/Obstetrics and Gynecology/Pulmonary and Sleep disorders/Traumatology & Surgery/Otorhinolaryngology will be eligible for additional 5 marks for the post of Contract Medic – field Duty. Other qualifications such as PG in Biochemistry/Forensic and Social Medicine/Occupational Health or Medicine and Rehabilitation/Physiology will not be eligible for additional 5 marks.

- iii) Further additional 5 marks shall be given to a Post Master's qualification in the relevant field (e.g. M.Ch/DM).
- iv) The qualifications considered for granting additional marks shall need to be in line for example an MBA in Hospital Administration shall not be considered as an inline qualifications where MBBS is the essential qualification.

2. PHYSIOTHERAPIST

a) **Qualifications:**

Essential: Masters in Physiotherapist from any recognized Indian or Foreign University. MPT in Sports will be preferred.

Work Experience: Minimum 3 years of work experience as Physiotherapist including 1 year working with sports academies/ Institutions.

b) Age: The maximum age shall not be more than 45 years on the last date of receipt of application.

c) Remuneration: Fixed remuneration of **Rs. 60,000/-** (Sixty Thousand only) per month.

GENERAL CONDITIONS FOR ABOVE 4 POSTS:

- **Tenure:** The contractual engagement will be for a period of one year, it may further increase up to three (3) years on the basis of satisfactory performance, periodic reviews, result oriented, etc. and at all times coterminous with the Khelo India Scheme.
- **MOU:** Selected candidates shall be required to sign a contract agreement as per terms and conditions of Khelo India. The contract shall end on expiry of the prescribed period and no separate notice shall be required to be given.
- **Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the State Sports Department will issue TDS /Service Tax Certificates, as applicable.
- **Other Allowances:** No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.
- **Extension:** Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review / requirement.
