The applicant should use only one application form for a position, even if he/she chooses to apply for more than one position in a CWC or JJB. Applicant wants to apply for more than one position shall submit different form. The applicant must be a resident of Tripura State. Applications sent by e-mail, WhatsApp, incomplete applications, applications without signatures, applications without the required eligibility criteria and the applications received after due date will not be entertained.

The applicants are requested to note that these appointments are not salary based employments. These are purely tenure based appointments to deal with the cases of the 'Children in need of care & protection' and 'Children in conflict with law', and they will be paid sitting allowance / honorarium as may be fixed by the State Government. The maximum term period of the Committee or the Board is 3 years.

Only those shortlisted applications, which fulfil the basic eligibility criteria and required qualifications, will be considered to place before the Selection Committee. The shortlisted candidates may be called for a personal interaction/interview with the Selection Committee for final selection at a venue which may be communicated later.
