Last Date for receiving applications till 12.01.2024

Applications are invited from the eligible candidates with requisite qualifications, in the prescribed application form, for serving as “Chairpersons & Members of the Child Welfare Committees” and “Social Worker Members of the Juvenile Justice Boards” for four and five districts of Tripura respectively under Juvenile Justice (Care & Protection of Children) Act, 2015/Amendment Act 2021 and the Juvenile Justice (CPC) Model Rules, 2016/Amendment Rules 2022.

The application with bio-data along with (self-attested) copies of the credentials should be submitted through online at <https://swserecruitment.tripura.gov.in/> before 12.01.2024 latest by 11:59 PM. The link is also available in the Departmental website i.e <https://socialwelfare.tripura.gov.in/>

The applicant should use only one application form for a position, even if he/she chooses to apply for more than one position in a CWC or JJB. Applicant wants to apply for more than one position shall submit different form. The applicant must be a resident of Tripura State. Applications sent by e-mail, WhatsApp, incomplete applications, applications without signatures, applications without the required eligibility criteria and the applications received after due date will not be entertained.

The applicants are requested to note that these appointments are not salary based employments. These are purely tenure based appointments to deal with the cases of the ‘Children in need of care & protection’ and ‘Children in conflict with law’, and they will be paid sitting allowance / honorarium as may be fixed by the State Government. The maximum term period of the Committee or the Board is 3 years.

Only those shortlisted applications, which fulfil the basic eligibility criteria and required qualifications, will be considered to place before the Selection Committee. The shortlisted candidates may be called for a personal interaction/interview with the Selection Committee for final selection at a venue which may be communicated later.
