- 1. APSERC reserves the right to keep any or all of the posts unfilled depending on the circumstances prevailing at the time of selection.
- 2. Only shortlisted candidates will be called for an interaction with the Selection Committee and no TA / DA shall be paid for attending the interview. Mere fulfilling of eligibility criteria shall not bestow any right to be called for interaction.
- 3. The posts mentioned in the above table are exempted from the principle of immediate absorption. Appointment under this assignment shall be purely on contract basis for a limited period only. Such appointment shall not vest any right to claim for regular appointment in APSERC.
- 4. Selected candidate shall be taken on deputation basis initially for a period of 2 years with the option for further extension based on his / her satisfactory performance and as deemed fit by the Commission.
 - The contract will be initially for a period of 2 years and thereafter extended on year to year basis based on the performance of the contractual officer / official.
- 5. Upto date ACAR / APARs dossiers of last three years are required to be submitted
- 6. The cut-off date for calculation of experience will be the date of advertisement.
- 7. Normal working hours would be as per the Order issued by the Government of Arunachal Pradesh from time to time.
